General Information about Turkish Visas:

It is highly recommended that foreigners, who wish to visit Turkey, should read the related information about Turkish visa regime.

Visa regime for Touristic and Business Purposed visit of a country may differ from Work and Education Purposed visit. Also Turkey's visa regime may change according to reciprocity principle.

While some applicants may be exempt from visa for their touristic or business visit to Turkey, the others can obtain an e-Visa. All other applicants will need to obtain a visa through Turkish Representations in the abroad.

must).

- 3. Copies of the recent and old passports along the used pages concerning visa entry and exit stamps (If it is relevant and not

empty pages!)

- 4. Two (2) recent colored biometric photographs of the applicant with the size of 5x5 cm and white background
- 5. Travel health insurance certificate covering the minimum of Euros 30.000, the period of stay in Turkey and the repatriation

costs as well

6. Polio vaccination certificate from the Government Hospitals or the authorized laboratories (The validity of the vaccination

should cover the travel period and the vaccination's date should not be more than one year old)

- 7. Copy of the flight reservation (Reservation only, not the ticket)
- 8. Copy of the hotel reservation (Reservation only) or invitation letter (Individual invitation letter should be prepared by the public Notary).

(The invitation letter shall include Turkish Identity Number, open identity, residential address and number of contact of the

inviting person, list of the invitees, duration and purpose of the visit, relationship with the applicant (if there is any) and the tax

number (if the invitation is made by the company). In addition, as incumbent on board and lodging, the inviting person must

declare in the mentioned invitation letter that board and lodging expenses will be met by the invitees themselves)

9. Employment letter stating the name, position, salary, profession or type of skill (if there is any) from the company (if there is

any)

10. Bank account maintenance certificate and original bank statements of the last three months [the current balance should

- 2. Passport / travel document valid for at least 6 months as from the date of your arrival in Turkey
- 3. Copies of the recent passport
- 4. Two (2) recent colored biometric photographs of the applicant with the size of 5x5 cm and white background
- 5. Note Verbal from Ministry of Foreign Affairs of Pakistan and Official Assignment Letter Conditional documents:
- 1. Consent letter of the parents arranged by the Notary (if the applicant is under 18 years old)

Education Purpose:

Main documents:

- 1. Visa Application Form duly filled (https://www.konsolosluk.gov.tr/Visa/Index), submitted on the online system, printed and signed by the applicant. (CNIC number, father and mother names, complete residential and host (if applicable) addresses are must).
- 2. Passport / travel document valid for at least 6 months as from the date of your arrival in Turkey
- 3. Copies of the recent and old passports along the used pages concerning visa entry and exit stamps (If it is relevant and not empty pages!)
- 4. Two (2) recent colored biometric photographs of the applicant with the size of 5x5 cm and white background
- 5. Travel health insurance certificate valid 90 days from the entry Turkey, covering the minimum of Euros 30000, and the repatriation costs as well
- 6. Polio vaccination certificate from the Government Hospitals or the authorized laboratories (The validity of the vaccination should cover the travel period and the vaccination's date should not be more than one year old)
- 7. Student Certificate /Acceptance Letter
- 8. Copy of the flight reservation (Reservation only, not the ticket)
- 9. Bank account maintenance certificate and original bank statements of the last three months of the student or the sponsor [the current balance should cover all the expenses (one-year tuition fee / course fee + air ticket + accommodation + food and beverages)] which are signed and stamped by the bank officer and guarantee letter of the sponsor (Affidavit) by the Notary (if there is any)

Employment Purpose:

Main documents:

- 1. Visa Application Form duly filled (https://www.konsolosluk.gov.tr/Visa/Index), submitted on the online system, printed and signed by the applicant. (CNIC number, father and mother names, complete residential and host (if applicable) addresses are must).
- 2. Passport / travel document valid at least 3 months beyond the expiry date of the work contract
- 3. Copies of the recent and old passports along the used pages concerning visa entry and exit stamps (If it is relevant and not empty pages!)
- 4. Two (2) recent colored biometric photographs of the applicant with the size of 5x5 cm and white background
- 5. Valid Police Character Certificate (Issued within last 6 months)
- 6. Polio vaccination certificate from the Government Hospitals or the authorized laboratories (The validity of the vaccination should cover the travel period and the vaccination's date should not be more than one year old)
- 7. Employment letter stating the name, position, salary, profession or type of skill (if there is any) from the company (if there is any)
- 8. Labor contract (the original or the copy of the contract made between the employer and the employee, notarization is not required)

Family Unification Purpose:

Main documents:

- 1. Visa Application Form duly filled (https://www.konsolosluk.gov.tr/Visa/Index), submitted on the online system, printed and signed by the applicant. (CNIC number, father and mother names, complete residential and host (if applicable) addresses are must).
- 2. Passport / travel document valid for at least 6 months as from the date of your arrival in Turkey
- 3. Copies of the recent and old passports along the used pages concerning visa entry and exit stamps (If it is relevant and not empty pages!)
- 4. Two (2) recent colored biometric photographs of the applicant with the size of 5x5 cm and white background
- 5. Valid Police Character Certificate (Issued within last 6 months)
- 6. Marriage Certificate and Original Family Registration Certificate
- 7. Travel health insurance certificate covering the minimum of Euros 30.000, the period of stay in Turkey and the repatriation costs as well
- 8. Polio vaccination certificate from the Government Hospitals or the authorized laboratories (The validity of the vaccination should cover the travel period and the vaccination's date should not be more than one year old)
- 9. Copy of the flight reservation (Reservation only, not the ticket)
- 10. Copy of the hotel reservation (Reservation only) or individual / company invitation printed letter arranged by the public Notary.

(The invitation letter shall include Turkish Identity Number, open identity, residential address and number of contacts of the inviting person, list of the invitees, duration and purpose of the visit, relationship with the applicant (if there is any) and the tax number (if the invitation is made by the company). In addition, as incumbent on board and lodging, the inviting person must declare in the mentioned invitation letter that board and lodging expenses will be met by the invitees themselves)

- 11. Employment letter stating the name, position, salary, profession or type of skill (if there is any) from the company (if there is any)
- 12. Bank account maintenance certificate and original bank statements of the last three months [the current balance should cover all the expenses (air ticket + accommodation + food and beverages)] which are signed and stamped by the bank officer.

Important Notes

Personal Appearance

- For Individual applicants personal appearance is must
- For family application, Appearance of head of the family is sufficient
- For group's: Company's Travel desk should contact Gerry's for appointment.

Visa Fee:

- Single entry fee: 7,350/- PR
- Multiple entries fee: 23,930/- PR (Multiple visas can only be granted if applicant has travelled before to Turkey)
- Single Transit: 7,350/- PR
- Multiple Transits: 14,700 /-PR

Visa fee is updates in beginning of each year

Applicants are required to submit 2 photos of 5 x 5cm taken in white background and type should be biometric, attached hard copy of photo must not be damaged.

• JPEG format should be uploaded (not scanned)

Applicants contact details must be mentioned on the form

- Landline number (residence and office number with extension)
- Mobile number
- Email address

Applicant must fill complete contact details of inviting company on the form.

• Applicant can write inviter's details manually in case if system doesn't print the details.

Application should be signed by each applicant if above 18 years of age. Otherwise for minors one parent can sign the application.

If depended child is traveling with one parent then affidavit from other parent is must along with parent's contact details. And similarly if child is travelling with relatives then affidavit from both parents is required. (Additionally if parents are separated then affidavit and separation certificate is required or if one parent has expired the death certificate is required)

If applicant's family/relatives lives in Turkey and applicants intend to stay with inviter then inviter's contact details must be mentioned along with copy of Turkish Kimlik, residence permit, residence address.

If applicant mentioned that he/she will travel with other person/family members/friends then copy of their visa and reservations is required.

(Copy of USA/ Schengen visa and eVisa or Turkish visa sticker obtained from another country)

Exception:

- Pakistani official passport holders are exempted from visa for their travels to Turkey up to 90 days.
- Pakistani ordinary passport holders with a valid Schengen, OECD member's visa or residence permit may get their one-month single entry visas online. E-visa is only valid when the purpose of travel is tourism or commerce. For work and study visas, applicants are required to get regular visa given by our Consulate. For further information, please follow the link on our home page and check www.evisa.gov.tr.
- Foreigner passport holders must have 6 to 8 months valid Pakistani visa.

Groups:

Companies/ Educational institutes will fill online e-appointment applications and each application will receive one reference number which is important for visa section to retrieve the data from the system but group will not take/click "appointment" rather will download the online form and then click "submit" the online applications and then group representative will bring all applications on the date suggested by the Consulate General through Gerry's.

For groups exceeding 50 passports, it is recommended to submit the application at the earliest date, if possible a few weeks before traveling.

Apply online visa

Step 2:

Bring print out of the Visa Application form, your passport (valid for more than 08 months), passport size photograph (5cm x5cm) along with other supporting documents mentioned on the Website as per your desired visa category.

When you arrive at the Gerry's visa drop box office you will collect a token, wait until your token is called to make your application at the submission counter.

Please hold on to your receipt as you will need this later to collect your documents.

Collect your documents from the Gerry's Visa Drop box office.
